- 4.2 GENERAL ADVICE:

4.3 EYE CONTACT:

SECTION 7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:

Electrostatic charge may accumulate and create a hazardous condition when pumping and handling this material. 7.2 CONDITIONS FOR SAFE STORAGE, INCLUDING ANY INCOMPATIBILITIES: Keep in fireproof surroundings. Keep separated from strong oxidants. Do not store above 49 C/120 F. Keep container tightly closed & upright when not in use to prevent leakage.
