# **SECTION 4) FIRST-AID MEASURES**

#### Inhalation:

Remove source of exposure or move person to fresh air and keep comfortable for breathing.

Eliminate all ignition sources if safe to do so.

# Skin Contact:

Rinse/wash with lukewarm, gently flowing water (and mild soap) for 15-20 minutes or until product is removed. If skin irritation occurs or you feel unwell: Get medical advice/attention.

# Eye Contact:

Remove source of exposure or move person to fresh air. Rinse eyes cautiously with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelids open. 
