The Drug Enforcement Administration (DEA) enforces the Controlled Substances Act, as amended, and all subsequent Acts to control chemicals that can be used in the clandestine production of controlled substances. The chemicals regulated under these Acts are known as List I and List II chemicals and are as follows:

**List I Chemicals**

A.G. Layne, Inc. does not offer any items in List I

**List II Chemicals:**

Acetic anhydride	Acetone
Benzyl chloride	Ethyl ether
Potassium permanganate	2-Butanone (or methyl ethyl ketone or MEK)
Toluene	Hydrochloric acid
Sulfuric acid	Methyl isobutyl ketone* (MIBK)
Sodium permanganate	Anhydrous hydrochloric acid (hydrogen gas)

The Acts and A.G. Layne's Product Stewardship/internal procedures, require A.G. Layne, Inc. to establish the identity of purchasers of List I and List II chemicals including mixtures containing these, and to report suspicious or unusual orders. A.G. Layne Inc. uses the attached DEA Authorized Purchaser Form to record and comply with requirements for establishing the purchaser's identity and requires all customers of List I and List II chemicals/mixtures to certify that the products ordered from A.G. Layne, Inc. will not be used directly or indirectly in the production of illicit drugs or chemical weapons, and provide the names and signatures of their authorized purchasing personnel on this form. These records will be updated annually.
